# [Draft for approval at the August 26, 2021 meeting] Yolo County Law Library Board of Trustees Minutes of the July 29, 2021 Meeting

The Yolo County Law Library Board of Trustees held a meeting on Thursday, July 29, 2021, scheduled for 12:15 PM, via Zoom online conferencing.

President Welton called the meeting to order at 12:17 PM.

Present: Trustees Cortés, Mack, Maguire, Meyer, Welton, Wolk. Staff: Coles

Absent: Trustee Blake

There was no public attendance, and no public comment was received.

#### **Action items:**

- 1) Consider approval of routine business.
  - a. The minutes of the June 24, 2021 meeting were approved.
  - b. June-July 2021 claims were ratified.
- 2) Financial report.
  - a. Court distributions for May 2021 were reported (\$9,326.01).
  - b. The Board approved the Library's 2021-22 budget for a total amount of \$177,015 (\$118,200 for cost center 7001, and \$58,815 for cost center 7002).
- 3) Director's Report. Director Coles provided a written report for the Board and discussed portions of it in further depth. The Board agreed that given the new requirement for indoor masking and the Library's inability to monitor that after hours, that the Board would put off considering a reopening for after-hours access for the present. Coles said that the Library would follow a staged approach for bringing up a new website for the Library, and that a home page with basic information about the Library and the Board of Trustees would be available for review and discussion at the next meeting. She also said that she was working with the Bar Association on a survey for its members, to be implemented in September, and that a draft of that survey would be presented to the Board at its next meeting for discussion and approval.

Coles stated that the Library had received official notice that it would have an allotment of \$58,815 from the state for both the 2021-22 and 2022-23 fiscal years. She also brought up the possibility of the Library gaining some additional funding by becoming a passport acceptance center. The Board agreed that this idea had promise and Coles stated that she would investigate more fully and report to the Board at its next meeting.

- 4) Next meeting. The next meeting will be held on Thursday, August 26, 2021.
- 5) Adjournment. The meeting was adjourned at 12:47 PM.
