### Reason for Recommended Action/Background

The recommended action is required by Assembly Bill 361 to continue meeting remotely during a declared state of emergency. It includes a finding that social distancing measures continue to be recommended, consistent with the most recent memorandum from the County Health Officer (Attachment A). This finding (or a finding that meeting in person would present imminent health and safety risks) is required on a monthly basis.

Subject: Remote Public Meetings

On September 22, October 20, and November 20, 2021, I issued memoranda recommending remote meetings. The case rate in Yolo County has increased significantly since the November 20 memorandum, and the current case rate represents high community transmission. In the context of high community transmission, I recommend meetings be held remotely whenever possible. I am re-issuing the earlier memorandum with updated COVID-19 case rate data.

In light of the ongoing public health emergency related to COVID-19 and the high level of community transmission of the virus that causes COVID-19, the Yolo County Public Health Officer recommends that public bodies continue to meet remotely to the extent possible. Board and Commissions can utilize the provisions of newly enacted AB 361 to maintain remote meetings under the Ralph M. Brown Act and similar laws.

Among other reasons, the grounds for the remote meeting recommendation include:

- The continued threat of COVID-19 to the community. As of January 4, 2022, the
  case rate is 32.3 cases per 100,000 residents per day. This case rate is
  considered "High" under the Centers for Disease Control and Prevention's (CDC)
  framework for assessing community COVID-19 transmission; and
- The unique characteristics of public governmental meetings, including the
  increased mixing associated with bringing together people from across the
  community, the need to enable those who are immunocompromised or
  unvaccinated to be able to safely continue to fully participate in public
  governmental meetings, and the challenges of ensuring compliance with safety
  requirements and recommendations at such meetings.

Meetings that cannot feasibly be held virtually should be held outdoors when possible, or indoors only in small groups with face coverings, maximal physical distance between participants, use of a portable HEPA filter (unless comparable filtration is provided through facility HVAC systems), and shortened meeting times.

### **RESOLUTION NO. LL-2021-01**

# A RESOLUTION AUTHORIZING REMOTE TELECONFERENCE MEETINGS PURSUANT TO ASSEMBLY BILL 361

WHEREAS, all meetings of the Yolo County Law Library Board of Trustees are held pursuant to the Ralph M. Brown Act, ensuring that any member of the public may participate in local government meetings; and

WHEREAS, on March 4, 2020, Governor Newsom proclaimed a State of Emergency in California as a result of the threat of COVID-19 and ordered all residents to obey orders and guidance issued by state and local health officials, including but not limited to, the imposition of social distancing measures to control the spread of COVID-19; and

WHEREAS, on March 9, 2020, the County of Yolo adopted a resolution ratifying the declaration of local health emergency and issued a proclamation of a local emergency related to COVID-19; and

WHEREAS, on March 17, 2020, in response to the COVID-19 pandemic, Governor Newsom issued Executive Order N-29-20 suspending certain provisions of the Ralph M. Brown Act in order to allow local legislative bodies to conduct meetings telephonically or by other means; and

WHEREAS, on June 11, 2021, Governor Newsom issued Executive Order N-08-21, which, effective September 30, 2021, ends the provisions of Executive Order N-29-20 that allows local legislative bodies to conduct meetings telephonically or by other means; and

WHEREAS, on September 16, 2021, the Governor signed AB 361 (2021) into law, which allows for local legislative bodies to continue to conduct meetings via teleconferencing under specified conditions and includes a requirement that the legislative bodies make specific findings; and

WHEREAS, the Governor has declared a State of Emergency pursuant to Government Code section 8625 as has the County of Yolo; and

WHEREAS, since issuing Executive Order N-08-21, the highly contagious Delta variant of COVID-19 has emerged, causing an increase in COVID-19 cases throughout the State and Yolo County; and

WHEREAS, the California Department of Public Health currently recommends that all individuals, regardless of vaccination status, wear a mask while indoors in public spaces; and

WHEREAS, on October 11, 2021, the Yolo County Public Health Officer issued an amended order requiring all individuals, regardless of vaccination status, to wear a mask while indoors in public spaces and to continue to follow the California Department of Public Health's and the Centers for Disease Control (CDC)'s guidance for vaccinated and unvaccinated people, including physical and social distancing measures to minimize the spread of COVID-19; and

WHEREAS, the CDC continues to recommend physical distancing of at least 6 feet from others outside of the household; and

WHEREAS, California Code of Regulations Title 8, section 3205 "COVID-19 Prevention," subparagraph (c)(5) states: "Training and instruction. The employer shall provide effective training and instruction to employees that includes the following: . . . (D) The fact that particles containing the virus can travel more than six feet, especially indoors, so physical distancing, face coverings, increased ventilation indoors, and respiratory protection decrease the spread of COVID-19, but are most effective when used in combination"; and

WHEREAS, because state and local health officials have imposed or are recommending measures to promote social distancing, the Yolo County Law Library Board of Trustees finds it prudent to and desires to continue holding meetings via teleconference; and

WHEREAS, the Yolo County Law Library Board of Trustees shall ensure that its meetings comply with the provisions required by AB 361 (2021) for holding teleconferenced meetings.

NOW, THEREFORE, the Yolo County Law Library Board of Trustees does resolve as follows:

- 1. The above recitals are true and correct, and incorporated into this Resolution.
- 2. In compliance with AB 361 (2021), and in order to continue to conduct teleconference meetings without complying with the requirements of Government Code section 54953(b)(3) of the Brown Act, the Yolo County Law Library Board of Trustees makes the following findings:
  - a) The Yolo County Law Library Board of Trustees has considered the circumstances of the state of emergency; and
  - b) The state of emergency, as declared by the Governor and County of Yolo, continues to exist; and
  - c) The state of emergency due to the presence of COVID-19 in the community continues to directly impact the ability of the members of the Yolo County

Law Library Board of Trustees to meet safely in person; and

- d) State and local officials continue to impose or recommend measures to promote social distancing.
- 3. The Yolo County Law Library Board of Trustees may continue to meet remotely in compliance with AB 361, in order to better ensure the health and safety of the public.
- 4. The Yolo County Law Library Board of Trustees will revisit the need to conduct meetings remotely no later than 30 days after teleconferencing for the first time, and every 30 days thereafter.
  - 5. This resolution shall take effect immediately upon its adoption.

# Yolo County Law Library Board of Trustees Minutes of the December 2, 2021 Meeting

The Yolo County Law Library Board of Trustees held a meeting on Thursday, December 2, 2021, scheduled for 12:15 PM, via Zoom online conferencing.

Trustee Maguire (acting for President Welton) called the meeting to order at 12:15 PM.

Present: Trustees Blake, Mack, Maguire, Meyer, Wolk. Staff: Coles

There was no public attendance, and no public comment was received.

#### Discussion and action items:

1) The RESOLUTION AUTHORIZING REMOTE TELECONFERENCE MEETINGS PURSUANT TO ASSEMBLY BILL 361 was approved. The Board noted that it would have to re-authorize remote teleconferencing each month, as long as the rules outlined in AB 361 remain in place.

### 2) Consider approval of routine business.

- a. The minutes of the October 28, 2021 meeting were approved.
- b. November-December 2021 claims were ratified.

### 3) Financial report.

- a. Court distributions for September 2021 were reported (\$9,408.47).
- b. Director Coles provided an income and expenditures report for FY2022 through November 30, 2021, showing a balance of \$23,838.85 for fund 7001 and -\$54,814.95 for fund 7002.
- 4) **Director's report**. Coles reported as follows:
  - a. The Library was on track to go live with its new catalog by February 1, 2022.
  - b. The new LexisNexis Digital Library service was expected to go live by the end of December 2021, meaning that the Library will soon be able to offer free remote access to California Forms of Pleading and Practice and the California Legal Forms Transaction Guide, as well as 14 additional Matthew Bender and James Publishing titles, to anyone in the county who wants to use them (users must register for access).
  - c. The Library was working on a list of solo and small law practices in Yolo County, with the goal of administering the legal professionals survey that was sent out in October to that target audience, with the hope of getting more response. The list should be completed by mid-December 2021 and the survey would be sent out again at that point. The Library will target sending out a public survey in January 2022.
  - d. The banner signs approved by the Board to mount on the fencing in front of the library were purchased and received and should be up by December 6, 2021. Locks were purchased to secure the banners to the fence.
  - e. As discussed at the October 2021 board meeting, the subject of establishing a kiosk at the courthouse for Westlaw and CEB OnLAW access was brought up with Trustee Maguire (as Presiding Judge for the Yolo Superior Court). Maguire consulted with the court administrator and said that the court was unwilling to allow this due to the potential impact on court personnel for requests for support, etc. The court administrator also questioned the need for a kiosk, given the proximity of the courthouse to the Library. Coles said that though the Library is not far from the courthouse, it's not in the immediate vicinity, and usage of those (costly) professional databases is very low. Another avenue mentioned was the possible use of the area set

- aside in the courthouse for the Yolo County Bar Association, which has computer equipment, etc., already installed. Coles said she would consult with the Bar Association president (Rafael Moore) and report back to the Board.
- f. The Library so far has been unable to get any response from the State Department on becoming a passport acceptance facility but will keep trying. Another possibility would be for Coles to become a notary and for the Library to then offer notary services; the Board responded positively to this idea and Coles said she would pursue it.
- g. Library Assistant Marie Drebert will be leaving her position on April 15, 2022. Coles said this would give the Library an opportunity to look at the Library's budget, needs and projects, and come up with an appropriate staffing plan.
- h. Coles mentioned that she is on a Council of California County Law Librarians committee to examine the needs of smaller, under-resourced county law libraries and develop recommendations for mutual aid for those libraries. The committee plans to finish its work by early spring 2022.
- i. The Library's FY2021 statistics were submitted to the California State Library and will appear in the statewide database.
- 5) **Next meeting.** The Board discussed the next meeting time, confirming that it would not meet on Thursday, December 23, 2021, but would go back to its regular meeting schedule (4<sup>th</sup> Thursday of each month, from 12:15-1 PM), in January 2022. The next meeting will be held on Thursday, January 27, 2022, at 12:15 PM.
- 6) Adjournment. The meeting was adjourned at 12:51 PM.
