


Q2 If/when you use the Law Library, what resources and services do you use (check all that apply)?





Q3 What keeps you from using the library, or using it more often (check all that apply)?




Q4 Which of the following types of library services would you use (check all that apply)? What else could the Library offer that would be useful for you?


