Resolution Authorizing Remote and Hybrid Teleconference Meetings of the Yolo County Law Library Board of Trustees Pursuant to Assembly Bill 361

Summary

The proposed resolution will allow the current Yolo County Law Library Board of Trustees Meeting to be held virtually.

Background

Meetings of the Yolo County Law Library Board of Trustees (Board) are conducted pursuant to the provisions of the Ralph M. Brown Act. The Brown Act has traditionally placed significant restrictions on teleconferenced meetings, including requiring that each teleconference location be accessible to the public (i.e., participation of Board members from homes or private offices has not been permitted).

In the early days of the COVID-19 pandemic, the Governor issued a series of Executive Orders temporarily suspending the restrictions on teleconferenced meetings, under which most YCTD meetings and those of its affiliated legislative bodies have been conducted during the last year-and-a-half. These Executive Orders terminated on September 30, 2021. In their place, the Legislature has enacted Assembly Bill 361 (R. Rivas), which permits legislative bodies to continue holding teleconferenced meetings without the traditional Brown Act restrictions (through December 2023) under any of the following circumstances:

- (A) The legislative body holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing.
- (B) The legislative body holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.
- (C) The legislative body holds a meeting during a proclaimed state of emergency and has determined, by majority vote, pursuant to subparagraph (B), that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

To continue holding teleconferenced meetings in the manner to which Board members and the public have become accustomed, the Board will need to make one of the determinations required by Assembly Bill 361. The "imminent risk" determinations are factually supportable, as the continued rates of transmission of the COVID-19 virus, including the Omicron variant, can indeed present imminent risks to the health and safety of some in-person attendees, particularly those with pre-existing health conditions.

If the proposed resolution making these determinations is approved, the current Board meeting will proceed as a remote meeting, in substantially the same manner as previous meetings during the past 18 months. (Assembly Bill 361 includes several additional

requirements for teleconferenced meetings, including providing an opportunity for "real time" public comment, and suspending the meeting in the event that remote connectivity is lost; however, these are all consistent with the Board's existing practices.)

Staff is working on the necessary steps to allow future Board meetings to be held primarily inperson in the Yolo County Law Library, while still permitting full remote participation for those members who are unable to attend in person, or, if they prefer, to participate virtually.

Recommendation

It is recommended that proposed Resolution Authorizing Remote and Hybrid Teleconference Meetings of the Yolo County Law Library Board of Trustees Pursuant to Assembly Bill 361 be approved.

YOLO COUNTY LAW LIBRARY BOARD OF TRUSTEES RESOLUTION NO. ____

RESOLUTION AUTHORIZING REMOTE AND HYBRID TELECONFERENCE MEETINGS OF THE YOLO COUNTY LAW LIBRARY BOARD OF TRUSTEES PURSUANT TO ASSEMBLY BILL 361

WHEREAS, the Yolo County Law Library (YCLL) is committed to preserving and nurturing public access and participation in its meetings; and

WHEREAS, the Brown Act, Government Code section 54953, subdivision (e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953, subdivision (b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and

WHEREAS, on March 4, 2020, the Governor proclaimed pursuant to his authority under the California Emergency Services Act, California Government Code section 8625, that a state of emergency exists with regard to a novel coronavirus (a disease now known as COVID-19); and

WHEREAS, on June 4, 2021, the Governor clarified that the "reopening" of California on June 15, 2021 did not include any change to the proclaimed state of emergency or the powers exercised thereunder; and

WHEREAS, as of the date of this Resolution, neither the Governor nor the Legislature have exercised their respective powers pursuant to California Government Code section 8629 to lift the state of emergency either by proclamation or by concurrent resolution in the state Legislature; and

WHEREAS, the continued rates of transmission of the virus and variants causing COVID-19 within Yolo County are such that meeting in person would present imminent risks to the health or safety of some attendees of public meetings, particularly those with pre-existing health conditions; and

WHEREAS, the Board of Trustees has considered the current circumstances of the state of emergency, and determined that the state of emergency continues to directly impact the ability of the members to meet safely in person

NOW, THEREFORE, BE IT RESOLVED by the Yolo County Law Library Board of Trustees as follows:

- 1. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.
- 2. A proclaimed state of emergency exists and as a result of the emergency, meeting in person would present imminent risks to the health or safety of some attendees, particularly those with pre-existing health conditions.
- 3. The Board of Trustees is hereby authorized and directed to conduct open and public meetings in accordance with Government Code section 54953, subdivision (e) and other applicable provisions of the Brown Act.
- 4. This Resolution is intended to enable the Board of Trustees to meet via teleconference in accordance with Assembly Bill 361 of 2021 (Statutes 2021, Chapter 165), whether solely by teleconference or via a "hybrid" combination of physical location and teleconference.
- 5. This Resolution shall take effect immediately upon its adoption and shall be effective for a period of thirty (30) days thereafter, unless extended pursuant to Government Code section 54953, subdivision (e)(3). Expiration of this resolution shall not prejudice any subsequent action to adopt another resolution in accordance with Government Code section 54953, subdivision (e) during the present or any future state of emergency.

Yolo County Law Library Board of Trustees Minutes of the March 24, 2022 Meeting

The Yolo County Law Library Board of Trustees held a meeting on Thursday, January 22, 2022, scheduled for 12:15 PM, via Zoom online conferencing.

Board President Welton called the meeting to order at 12:15 PM.

Present: Trustees Blake, Cortés, Maguire, Mack, Meyer, Welton. Staff: Library Director Coles

Absent: Trustee Wolk

There was no public attendance, and no public comment was received.

Discussion and action items:

1) Renew authorization for remote (teleconference/videoconference) meetings.

The Board voted to renew its authorization for remote meetings, but President Welton noted that the County had recently issued updated guidance for in-person meetings and the next board meeting may take place in person.

2) Consider approval of routine business.

- a. The minutes of the January 27, 2022 meeting were approved.
- b. February and March 2022 claims were ratified.

3) Financial report.

- a. Court distributions for December 2021 (\$7,924.55) and January 2022 (\$7,779.97) were reported.
- b. Coles provided an income and expenditure report for FY2022 through showing a balance of \$14,309.62 for fund 7001 and -\$40,057.17 for fund 7002. She mentioned that the overage for fund 7001 is due mostly to the County's having transferred income received in July and August 2021 to the reserve fund, which was mentioned at a previous meeting. Coles said that she would provide a revised budget to the Board at its next meeting that would address that issue and include some minor categorical adjustments. Coles said that overall spending for the year would not exceed the total approved by the Board last June.

4) Approval of fees for community fairs.

The Board voted to approve the entry fees and auxiliary costs for brochures and other handouts for the Law Library to have booths at two local community fairs: Celebrate Davis and the Yolo County Fair. Costs for both were estimated at around \$1100.

5) Consider commendation for Assistant Librarian Marie Drebert.

The Board approved a resolution commending Assistant Librarian Marie Drebert for her service to the Yolo County Law Library. Marie is retiring at the end of April 2022 and moving to another part of the country.

6) Board positions for 2022.

The Board voted that Trustee Wolk would be the Board President starting July 1, 2022. Trustee Welton will serve as vice president. It was mentioned that as Trustee Blake will be retiring at the end of the year, the role of Board Secretary will also need to be filled soon. There was discussion about whether there were established terms for Board members and officers, and about the need to update the Board's bylaws. Trustee Welton said that she would work with Trustee Wolk as the new Board President to update the bylaws over the next few months and present them to the Board for review.

7) Director's report.

Coles submitted a written report to the Board before the meeting and went over the main points, including:

- Library Assistant Marie Drebert's last day in the office is April 14, 2022. The process of hiring her replacement is underway.
- Traffic in the Law Library has picked up recently, which hopefully will continue.
- Coles paid a visit to John Zorbas, Butte County Law Library Director, and got some valuable pointers on budget/collection planning.
- The results of the public survey that closed in February were summarized; Coles said the survey provided some valuable information about library services and collections that can be used for strategic planning.
- 8) Next meeting. The next meeting will be held on Thursday, April 28, 2022, at 12:15 PM.
- 9) Closed session. The Board went into closed session at 12:39 PM.
- 10) Adjournment. The meeting was adjourned at 1:03 PM.




